2013 TRIPS

Congratulations to all the 2013 Fellows and faculty who made this year's trips so successful! Our first trip, which included 14 journalism and 14 law students, started at the Museum of Jewish Heritage on Sunday, May 26 and ended in Nuremberg on Thursday, June 6. Our second trip started hot on the heels of the first, with 14 seminarians and 15 medical students gathering in New York on Sunday, June 16.

Forced to travel to Poland first because of logistical needs, the program ended in Berlin on June 27.

As usual, FASPE faced several logistical hurdles during the 2013 trips, including a 7-hour delay and layover for the Medical and Seminary groups in Berlin's Tegel Airport. While many spent much of that time in the few coffee shops that provide free wifi, the group also managed to find a seminar room where a group discussion was held on "Preparing Oneself for Emotionally and Ethically Fraught Work." Thorin also spent some of the time developing a Tegel Airport Scavenger Hunt that will be ready next time, just in case. If anyone has time to waste in Tegel, feel free to ask Thorin for the activity sheet.

In other news, FASPE was delighted to welcome three new faculty members in 2013: Sheila Coronel (Journalism), Nancy Wiener (Seminary), and Lisa Lerman (Law).



Sheila, the Toni Stabile Professor of Professional Practice in Investigative Journalism at Columbia University, brought a wealth of experience from her career as an investigative journalist in the Philippines to seminars where she demonstrated her dynamic personality. Sheila, along with Professor Ari Goldman, engaged students in discussions that often carried on outside the classroom.

Lisa Lerman, a Professor of Law at Catholic University's Columbus School of Law, helped reshape the FASPE Law curriculum with a variety of case studies drawn from her textbook, *Ethical Problems in the Practice of Law*. Together with Eric Muller, the Dan K. Moore Distinguished Professor in Jurisprudence and Ethics at the UNC School of Law, the law curriculum focused heavily on the ethical issues that confront lawyers on a day-to-day basis.

Rounding out the new FASPE faculty was Rabbi Nancy Wiener, Clinical Director of the Jacob and Hilda Blaustein Center for Pastoral Counseling, Hebrew Union College-Jewish Institute of Religion. Working alongside LeRoy Walters, Professor Emeritus at Georgetown University, and Kevin Spicer, the James J. Kenneally Distinguished Professor of History at Stonehill College, Nancy added a variety of sessions that focused particularly on pastoral duties and challenges.

While no new faculty joined our Medical program, Dr. Jack Hughes, Professor of Medicine at Yale School of Medicine, returned for his third year with FASPE and

directed discussions with aplomb.

MEET OUR 2013 NAMED FELLOWS

Naming a FASPE fellowship is a meaningful and extremely helpful way to support the program. In 2013, FASPE received gifts to name two fellowships.

The first, as announced in the March edition of the FASPE E-Newsletter, came from Yossi Sagol who honored the Chairman of the Board of Trustees of the Museum of



Jewish Heritage with his gift. We are pleased to announce that the 2013 Robert M. Morgenthau FASPE Law Fellow is Leslie Esbrook, a member of the 2015 class of Yale Law School. Before entering law school, Ms. Esbrook was the valedictorian at Vanderbilt University, where she studied French and Economics. She also spent two years teaching English in rural Turkey through a Fulbright scholarship. In her application to FASPE she described her current focus: "My interest in the field of law relates to the conception of justice as a means of returning society to its 'proper

balance,' or a state that allows individuals to continue to effectively participate in society and define themselves as members of that community." Emphasizing what she hoped to gain from the program, she added "I wish to make the discussion of ethics in the field of law much more prominent and bring back what I learn in FAPSE to the law school through reading groups, a lunch time seminar, or other interactive programs." After her FASPE Fellowship, Ms. Esbrook returned to Turkey for the rest of the summer, but we are confident that she will be sharing what she learned during our trip with other law students in New Haven when she returns.

The second named fellowship in 2013 was created by 73 different FASPE alumni who



made generous contributions through our Alumni fundraising drive last year. We are pleased to announce that their contributions helped cover some of the travel costs for Alexandra Charrow, the 2013 FASPE Alumni Fellow. Ms. Charrow, who just completed her third year at the Perelman School of Medicine at the University of Pennsylvania, grew up in Chevy Chase, Maryland and earned her BA from Yale. In her application essay she described some of the challenges she had seen in medical school, saying "like many"

medical students, my year in the clinics complicated my initially naive view of medicine as I realized the power of medicine not only to create wellness, but to define sickness. My year in the clinics was a pendulum swinging between moments of true closeness with patients at their lowest points and time spent at great emotional distance, clouded with judgments of the patient's body, health, and life-choices...My dream in participating in FASPE is to enrich my practice with ethical nuance—combining my ambitions before clinics with my aspirations since completing them." Her dream is one that we share for all our Medical Fellows.

FASPE is deeply grateful to the contributors who made these two named fellowships

possible and hopes to be able honor additional students and funders in the years ahead with other named fellowships.
